Dear Staff & Parents at Ring Elementary School:

The New York State Department of Health (NYSDOH) requires public school districts to periodically test all drinking water fixtures for elevated levels of lead and to develop and implement a lead remediation plan, where applicable.

In accordance with this requirement, the District completed drinking water testing in all school buildings in June 2021. Having recently received the lab test results, we learned that certain water samples contained elevated levels that exceeded the reporting threshold of 15 parts per billion (ppb).

At Ring Elementary School, a total of 90 water outlets were sampled, and 32 of these samples exceeded the reporting threshold of 15 ppb. For a list of outlets where water samples exceeded the reporting threshold, please visit http://jpsny.org/leadtesting.

All water outlets with samples that exceeded 15 ppb have been taken out of service or marked with signs for individuals to know that those sources should not be used for drinking water. At this time, we believe that systematic flushing and/or changing out the fixtures will successfully remediate any elevated lead levels. We will have these outlets retested after the remediation plan is implemented to ensure that these outlets do not exceed the reporting threshold prior to being used again.
