21st CCLC End-of-Year Program Summary 2020-2021





PROGRAM OVERVIEW





Beginning in 2017, the Jamestown Public School District was awarded a Round 7 21st Century Community Learning Center (CCLC) grant.

This five-year grant from the NY State Education Department funds the PROMISE program, an afterschool program focusing on academic and enrichment activities at six sites in the district.

PROMISE specifically aims to support economically disadvantaged students and English Language Learner or Hispanic students. To this end, the program offers Afterschool Amigos (ASA) and La Promesa at three sites, which provide bilingual tutoring and family engagement activities for Hispanic students or students learning English.


Students and their family members, staff and administration at the schools, and the YWCA, YMCA, and Striders are the key stakeholders in this project.




Program Overview: Who attends






Engagement: Students

As expected, the number of attendees decreased from last year.


The program aims to serve 455 students each year. Students who attended 90 or more hours of program are considered regular participants. During the 18-19 school year, "Not regular" participants are students who attended at least 30 hours of program. Due to the COVID-19 pandemic, students who attended any number of program hours are counted as participants for the 19-20 and 20-21 years only.



Note: Participation numbers for the 19-20 school year only reflect participation up to March 13, 2020 due to the school shutdown prompted by the COVID-19 pandemic.





This objective could not be measured because no ELL students achieved regular attendee status.


Outcomes: ELA Academic Achievement

55% of regular attendees will achieve a 50+ growth percentile on the English portion of the NWEA MAP assessment.




Outcomes: Math Academic Achievement

55% of regular attendees will achieve a 50+ growth percentile on the Math portion of the NWEA MAP assessment.




Outcomes: Attendance


Outcomes: Behavior Change

KEY FINDINGS & NEXT STEPS



KEY FINDINGS



The program met outcome objectives for all that could be measured.

Despite an extremely challenging school year, the program exceeded the targets on all measurable outcome objectives relating to academic achievement and student behavior and attendance.



Focus on program recruitment and retention in Year 5.

With the potential of students returning to in-person learning next year, program staff should focus on the recruitment and retention of program participants in Year 5. Program staff should work with partners to determine how to best provide after-school program services.





Prepare additional academic support activities.

In the fall, students are going to need continued academic supports to regain some of the learning loss caused by the pandemic. Plan intentional, targeted support activities to help those students who need it most.



Plan for proper support around social-emotional activities.

With schools potentially bringing back all students in-person next school year, program staff should work to ensure the social-emotional needs of students are met while they transition back to school. Consider offering more social-emotional activities to support students during this difficult time.
